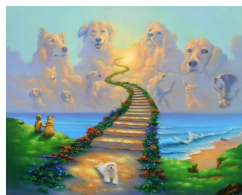

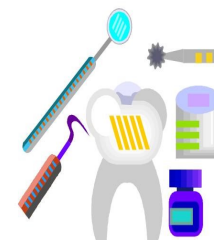

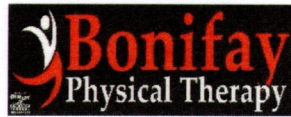

Preface: The Sunny Hills MSBU was established by Washington County Ordinance 2001-4 and amended by County Ordinances 2007-2, 2009-2, 2011-05, 2013-1, 17-03, and Resolution 17-08. Puts into effect a non-ad valorem assessment on all parcels of property within the Sunny Hills/Oak Hills Benefit Unit.

Purpose: To supplement and improve the community services provided by Washington County or the State of Florida within the benefit unit and are not intended to relieve Washington County or the State of Florida from providing services. Community services include but are not limited to such things as road improvements, street and security lighting, improvements to common areas, and beautification.

Projects completed or implemented during the year(s) in review include the following:

- Installation of an electronic message board at the main Sunny Hill entrance. NOTE: Contact the MSBU Coordinator to have a message added to your sign.
- Rebuild and refurbish of the fountain at the main entrance into Sunny Hills.
- Purchased new flags for the main entrance of Sunny Hills.
- Update lighting at main entrance
- Update Sunny Hills Blvd lighting
- Coordination and award of a contract to provide for roadside mowing and trash pick-up on certain roads to enhance to beauty of Sunny Hills and show our community in a positive light.
- Complete rebuild of eight (8) solar streetlights that were installed by a previous MSBU Committee years ago.
- Streetlights: Installed new streetlights at the intersections of Elcam Blvd and Deltona Blvd, Newcomb Rd and Viking Rd, and Shenandoah and Challenger. Also, got the parking lot lights updated and operational at Wilder Park.
- Coordination continues with the county to get Wilder Park updated and fully operational. Main areas of concern are Bathroom Facilities and Water. New fencing is currently being contracted by the county and is in the works. This is an on-going effort.
- Resurfaced approximately 3.5 miles of road.
- Installation of two (2) fire hydrants.

Projects on the horizon:

- Striping of newly paved roads
- Install new pump for northside fountain
- Install new lights at main entrance

The MSBU Committee welcomes everyone to participate in the scheduled meetings, which are posted on the electronic sign and county website. Your participation will help to identify how you would like to see your MSBU dollars allocated.
