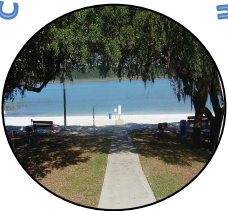

# Fall is upon us, Start your Dinner tonight right!



## Grilled Shrimp Panzanella



Make sure you use very crusty bread for panzanella so it doesn't get too soggy when it soaks up the dressing.

YIELDS: 4 - 6 servings

PREP TIME: 0 hours 25 mins

TOTAL TIME: 0 hours 25 mins



**Ingredients** 1 1-pound loaf crusty Italian bread, cut into 1-inch cubes (12 cups) 1/2 c. plus 2 tablespoons olive oil 3 garlic cloves, grated 1/4 tsp. red pepper flakes 1/2 tsp. kosher salt, plus more taste 1 1/2 lb. large shrimp, peeled and deveined 1/4 c. red wine vinegar 2 lb. tomatoes (red and/or yellow), cut into 1-inch chunks 1 small red onion, thinly sliced 3/4 c. pitted kalamata olives, thinly sliced 2 tbsp. drained capers, chopped 1/2 c. fresh basil, chopped

**Directions** Preheat the oven to 275°. Spread the bread on a baking sheet and bake until slightly crisp (like stale bread) but not toasted, 20 to 25 minutes. Let cool.

Preheat a grill to medium high. Whisk 2 tablespoons olive oil, the garlic, red pepper flakes and a pinch of salt in a large bowl. Add the shrimp and toss. Set aside while you assemble the salad.

Whisk the vinegar and remaining 1/2 cup olive oil in another large bowl. Add the tomatoes and onion and season with 1/2 teaspoon salt. Add the olives, capers, bread cubes and basil. Toss and let sit at room temperature while you grill the shrimp.

Grill the shrimp, turning once, until just opaque, 3 to 4 minutes. Once the shrimp are cooked, taste a bread cube. If it's a bit dry, drizzle the salad with a few tablespoons of water and toss. Add the grilled shrimp to the salad and toss.

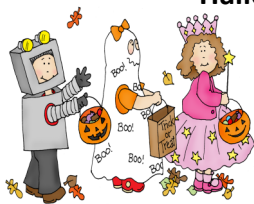
